

<p>Clarification regarding projects to be included in the Single Large Completed Contract (SLCC) for the Procurement of Human Resource Management System (HRMS) for the NDCP</p>	<p>In reference to the 2016 Implementing Rules and Regulations of RA 9184 Section 23.4.1.3 which states that:</p> <p><i>"The prospective bidder must have completed, within the period specified in the Invitation to Bid, an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC. However, in the case of Expendable Supplies, said SLCC must be at least twenty five percent (25%) of the ABC."</i></p> <p><i>"...The Procuring Entity may clarify in the Bidding Documents the definition or description of what it considers to be a similar project."</i></p> <p>Pursuant to the reference above, the Technical Working Group has defined the projects which is considered to be similar. Said projects is stated in the Bid Data Sheet of Bidding Documents under ITB Clause 5.3:</p>
