AND

**DESIGN AND FUNCTION INCORPORATED**, a cooperative duly registered under the laws of the Republic of the Philippines with principal office address at Unit 2609 26/F Prestige Tower Condo, Don F. Ortigas Road, Ortigas Center, San Antonio District I, Pasig City represented herein by its President, **MS PRECILLA M. MANGUBA** herein referred to as the "**SUPPLIER**".

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services viz., Procurement of Furniture and Fixtures for the National Defense College of the Philippines has accepted a Bid in the sum of **THREE MILLION SEVEN HUNDRED FORTY EIGHT THOUSAND TWO HUNDRED EIGHTY ONE PESOS ONLY (P3,748,281.00)** hereinafter called "the Contract Price"

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- k) Net Financial Contracting Capacity
- l) Credit Line issued by a licensed bank, if any
- m) Notice of Award of Contract and the Bidder's conforme thereto
- n) Other Contract documents that may be required by existing law and/or the Procuring Entity

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of the Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.


